

ECIS X DAIGON Esports Competition 2025 – Terms and Conditions

The ECIS x DAIGON Esports Competition will take place January - May 2025. The competition will be delivered in partnership with DAIGON Esports.

Registration

- The ECIS x DAIGON Esports Competition is open to ECIS member schools, including Applicant schools. Each school with a registered ECIS account must participate as an individual school.
- Those who register from non-member schools will be denied access to the competition.
- Schools must register their students for the event via the online form on the ECIS website.
- The closing date for registration is Friday 20 December 2024.

Student Squads

- Age brackets: Under 12, Under 15 and Under 18, based on a student's age on 1 September 2023. The suggested minimum age for participation is 8 years old.
 - U18 born after 1 Sept 2005
 - U15 born after 1 Sept 2008
 - U12 born after 1 Sept 2011
- A squad consists of the students registered for the competition; a team will be nominated ahead of each game. In a game of Rocket League, 3 players will take part; in a game of Minecraft 'Capture the Flag', 5 players will take part.
- Rocket League squad: minimum 3 players, maximum 4 players.
- Minecraft 'Capture the Flag' squad: minimum 5 players, maximum 7 players.
- Schools can enter up to 2 squads per game, per age bracket. Additional squads may be allowed, depending on capacity.
- Students can only be a part of 1 squad per age group, per game.

Competition Dates

- 30 January 2025 All entered teams.
- 06 February 2025 All entered teams.
- 13 February 2025 All entered teams.
- 13 March 2025 All entered teams.
- 20 March 2025 All entered teams.
- 27 March 2025 All entered teams.
- 10 May 2025 Competition Final, qualifying teams only
- Games will take place live at 15.00 in GMT/London. Other times and time zones will be considered based on the geography of participating schools.

Finance

- 35 GBP (5GBP per student per week)
- Invoices will be raised by DAIGON. Schools must pay the participation fee in a timely manner, in accordance with the timeline specified on the invoice.
- If a school does not pay their fee by the date shown on the invoice, their place will be revoked.
- If a team withdraws after 20 December 2024, the fee will still be payable, and any payments received will be retained.

1. INTRODUCTION

- 1.1If you use or continue to use this website ("Site") you are agreeing to comply with and be bound by the following terms and conditions of use, which governs our relationship with you for use of the Site. The Site is intended, among other purposes, for registration and bookings for the Welcome to our ECIS x DAIGON Esports Competition 2025 intended to take place on January – May 2025 ("Competition").
- 1.2 The term "Educational Collaborative of International Schools", ("ECIS" or "us" or "we") refers to the owner of the website whose registered office 7 Pancras Square, London N1c 4AG. The term "you" refers to you as a user or viewer of the Site. When you register with (or otherwise access) the Site or make a booking for the Competition, you are contracting with ECIS. You must be at least 18 years old to register or make a booking.1.3 The Site is intended only for the purposes specified on the Site from time to time.

2. BOOKING

- 2.1 All applications to register for the Competition must be made via the Site (or directly to ECIS) and all bookings are subject to availability and our receipt of full payment.
- 2.2 Confirmation (or rejection) of your booking will be sent to you by email within five (5) working days of our receipt of your booking request.
- 2.3 Delegate passes issued for use at the Competition are valid for the named attendee only and, subject to clause 4.2 below, cannot be transferred. You may be asked for photographic ID during the Competition and, if you are unable to provide such identification which matches your delegate pass, you may be asked to leave the Competition premises without refund or other recourse.
- 2.4 Should anyone in your party be diagnosed or suspected of having a contagious disease (including any disease which has the potential to infect other people in a short period of time), they will be asked to leave the Competition and the location (or, if this is not possible, restrictions will be placed upon them to prevent the virus being transmitted to others). Please note that we are unable to offer refunds in such circumstances and we recommend you take out suitable personal insurance to include sickness cover.
- 2.5 Please note that this Agreement and your booking agreement shall apply to (and it is your responsibility to procure compliance by) all members of your party. Failure to disclose all relevant information or to comply with all agreed terms may lead to termination of the agreement and loss of your booking.
- 2.6 If you have any special requirements, or if a member of your party has restricted mobility or access requirements, you must notify us at the time of booking. We will do our best to meet these requirements but please note that this cannot always be guaranteed.

3. PRICES AND PAYMENT

- 3.1 Our prices for attending the Competition are exclusive of VAT. Prices are subject to change from time to time.
- 3.2 If your booking has been confirmed, an invoice will be sent to you within five (5) working days setting out the relevant payment instructions and terms and full payment must be received within fourteen (14) days.
- 3.3 If you apply to register for the Competition less than two (2) weeks before the date of the Competition, we will accept payment only by a credit card (unless expressly agreed otherwise in writing). If for any reason we have not received payment in full by the date of the Competition you (or the attending delegate) will be asked as a condition of being allowed to attend the Competition to provide payment by credit card on the day of the Competition. If payment is not made at the time of booking, registration will be provisional. Registration and attendance is not confirmed until ECIS receive payment. We reserve the right to cancel your booking at any time if payment has not been received.
- 3.4 Once payment has been received in full, an email confirmation and payment receipt will be sent.
- 3.5 The reference number for your payment must be provided using your confirmed invoice number.
- 3.6 Exhibitors. If you are a customer:
- 3.6.1 in the UK: UK VAT chargeable and accounted for through UK VAT registration of 20%;





- 3.6.2 in any other EU Member State in which we are currently VAT registered: VAT chargeable in Member State of recipient and accounted for through our VAT registration in that Member State;
- 3.6.4 in an EU Member State in which we do not currently have a VAT registration: Reverse charge supply, recipient responsible for local VAT owed in Member State in which they belong;
- 3.6.5 in a country outside the EU: outside the scope of EU VAT;
- 3.6.6 outside the EU, no VAT will be charged.

4. CHANGES TO THE COMPETITION DATES, TIMINGS, PROGRAMME OR VENUE

4.1. ECIS reserves the right to make alterations at any time (with or without notice) to the Competition programme, venue and timings. If we alter the time and/or location of the Competition, we will provide you with as much notice as practicably possible. In some cases, we may offer the choice of either a credit for a future event (or a of future events) up to the value of sums already paid by you.

5. CANCELLATION POLICY

- 5.1 All cancellation requests must be submitted in writing to: <u>events@ecis.org</u>. If you are unable to attend the competition, you must contact ECIS with the name, job title and email address of your proposed substitute, provided such notice is received by us at least two (2) weeks prior to the start of the Competition and payment has been received in full. A £30 admin fee will be charged via invoice for any such change.
- 5.2 If we receive a cancellation request from you before 20 December 2025, you will receive a 100% refund of the delegate fees received from you. After such date (being 2 months prior to the event start date) we will refund up to a maximum of 50% of the fees received from you. We will not be able to honour any fee refunds for cancellations received within one month of the start date of the Competition.
- 5.3 We shall not be liable or responsible to you for any failure to perform, or delay in performance of, any of our obligations caused by or in connection with events outside our reasonable control (including without limitation legally-imposed quarantine or sanction, acts of God, adverse weather, fire, acts of terrorism or threats of any such acts, strike action, lock-outs or other industrial action and a pandemic, epidemic or other widespread illness).
